It is important that you respond positively and enthusiastically to this challenge. The enclosed brochure describes how the program works and the different areas of practice.



Every day there are at least one or more indigent persons who contact Westchester/Putnam Legal Services asking for legal help and yet are unable to obtain assistance due to lack of adequate funding and volunteer attorneys. Some become pro se litigants; most simply continue on with their civil legal needs unfulfilled.

If you will join the Volunteer Attorney Program, you will be doing the judiciary and the citizens of these counties and yourself a great service. I know that you will find this work very rewarding and in keeping with the best traditions of the legal profession to insure access to justice for all.

My esteemed predecessor as Administrative Judge of the Ninth Judicial District, the late Joseph F. Gagliardi, established the program many years ago. I am informed that efforts are currently underway to expand the initiative. I strongly encourage you to agree to participate.
