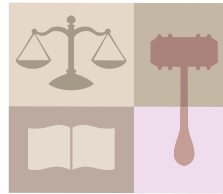
Library Programs

Ask a Lawyer in the Library is a civil self-help program, sponsored by the Maryland Volunteers Lawyers Service with the Anne Arundel Bar Association offered weekly at the Law Library in the courthouse and monthly at the **Glen Burnie Regional Library** and the **Eastport Annapolis Neck Community Library**.

Volunteer attorneys provide brief, limited legal advice for at least 20 minutes. Time slots are determined by lottery 15 minutes before the program start.

Issues that may be addressed

include: debt, landlord/tenant, real estate, contracts, consumer disputes, expungement, wills and estates.

Assistance, by the Maryland Volunteer Lawyers Service, is available through the Law Library. The library provides intake and will scan documents to MVLS. An MVLS attorney will then make arrangements for a follow-up phone call.

The Anne Arundel County Family Law Self-Help Center (FLSHC) is located in the back of the Law Library. The FLSHC is funded by the court but staffed by Legal Aid. The attorneys provide free assistance with family law matters such as divorce, custody, child support, and name change.
